- 1. The original invoice or sales receipt (showing date of purchase, product code and dealer's name) MUST accompany the defective product, along with a statement detailing the fault. In the absence of this clear proof of purchase, Yamaha reserve the right to refuse to provide free of charge service and the product may be returned at the customer's expense.
